A general account of how Denmark has developed over more than a thousand years, focusing on Denmark's political, social, and international conditions.

Jespersen, Knud J. V., A History of Denmark, London: Palgrave Macmillan, 2011.

A general history of Denmark, which traces the historical roots of the modern Danish state and Denmark's international position today.

Broad Treatments of Danish West Indian History

Bregnsbo, Michael and Kurt Villads Jensen, *The Rise and Fall of the Danish Empire*, Cham: Springer, 2022.

The book examines the Danish empire since the Viking age in Europe, India, Africa, and the Caribbean, including the economic and ideological benefits of an empire structure. This book is a translated and revised version of *Det danske imperium – storhed og fald*, København: Aschehoug, 2004.

Brimnes, Niels m.fl, red., Danmark og kolonierne, vol. 1-5, København: Gads Forlag, 2017.

A comprehensive general history of Denmark's colonial history. It is the new standard reference work. The volumes on *Vestindien*, *Vestafrika*, and *Danmark* are mentioned below, the two other volumes on *Indien* and *Grønland* are not.

Anthology containing a general history of the Danish West Indies as well as articles on specific topics. Texts are in English and Dutch.

Mulich, Jeppe: In a Sea of Empires. Networks and Crossings in the Revolutionary Caribbean, Cambridge: Cambridge University Press, 2020.

The book explores the interconnected nature of imperial politics and colonial law in the Caribbean, especially regarding the transnational networks involved in trade, slavery, smuggling, privateering, and marronage, emphasizing the border-crossing nature of life in the region.

Danish efforts, through 'The Danish Church Cause', to revitalize the Lutheran community in the Danish West Indies between 1902 and 1917.

Cohen, Judah M., Through the Sands of Time. A History of the Jewish Community of St. Thomas, U. S. Virgin Islands, Lebanon: Brandeis University Press, 2004.

The Jewish community was established in 1796 on St. Thomas, where Jews have played an important role ever since in the economic, social, and cultural life of the island.

Frendrup, Willy, Den katolske kirke i de danske tropekolonier, København: Ælnoth, 2008.

The main focus of this book on the Catholic church in the Danish tropical colonies is on the Danish West Indies, where Catholics at times made up the largest religious community among several others, especially on the cosmopolite St. Thomas.

Johansen, Julie Fryd m.fl., red., *Skoler i palmernes skygge*, København: Dansk Skolemuseum, 2008. Studies in the history of schools and teachers in the Danish West Indies, as well as the role of education in Danish colonial policy in general.

Sensbach, Jon F., *Rebecca's Revival. Creating Black Christianity in the Atlantic World*, Cambridge: Harvard University Press, 2006.

Rebecca Protten, née Freundlich, (1718-1780) was a free colored who became a Moravian missionary, preaching both in St. Thomas and later on the Gold Coast.

Life and times of Jacob Dischingthun (1723-1776), a Norwegian sailor who participated in direct West India voyages, transatlantic slave trade, and died as harbormaster in Christiansted on St. Croix.

Rönnbäck, Klas, Commerce and Colonisation: Studies of Early Modern Merchant Capitalism in the Atlantic Economy, Gothenburg: University of Gothenburg School of Business, Economics, and Law, 2009.

A study of development of the considerable profits gained in the Atlantic (and Baltic) trade under the Danish flag.

The history of the prehistoric and historic settlement of Water Island situated in St. Thomas harbor.

A general history of Danish transatlantic slave trade, including transcription of the comprehensive report of 1791 which led, in 1792, to the royal decree to abolish the transatlantic slave by 1st January 1803.

A significant general history of Danish forts and factories on the Gold Coast, 1660s-1850, with chapters representing the most actual research results, especially regarding interaction between Danes and local African societies. It is the new standard reference work with comprehensive lists of literature and archival records.

Highfield, Arnold R. and George F. Tyson, eds., *Negotiating Enslavement. Perspectives on Slavery in the Danish West Indies*, St. Croix: Antilles Press, 2009.

Sixteen papers from annual meetings of the Society of Virgin Islands Historians, discussing different aspects of the Danish West Indian slave society.

Hopkins, Daniel, Peter Thonning and Denmark's Guinea Commission. A Study in Nineteenth-Century African Colonial Geography, Leiden and Boston: Brill, 2013.

Peter Thonning (1775-1848) was a natural historian and influential government official involved in the vain Danish policy of plantation production on the Gold Coast.

Ipsen, Pernille, Daughters of the Trade. Atlantic Slavers and Interracial Marriage on the Gold Coast, Philadelphia: University of Pennsylvania Press, 2015.

Five generations of interracial marriages between African women and Danish men on the Gold Coast between the early eighteenth century and the mid-nineteenth century created a Euro-African hybrid culture specifically adapted to the transatlantic slave trade.

Jensen, Niklas Thode, For the Health of the Enslaved. Slaves, Medicine and Power in the Danish West Indies, 1803-1848, Copenhagen: Museum Tusculanum Press, 2012.

The structure of the medical world on St. Croix, the health policy of the Danish colonial administration, and the power over the health of the enslaved, with a special focus on demography, nutrition, diseases, vaccination, and midwives.

Jensen, Niklas Thode and Vibe Martens, eds., *Slavery, Servitude and Freedom. New Perspectives on Life in the Danish-Norwegian West Indies, 1672-1848*, Oxon: Routledge, 2016 (Special Issue of Scandinavian Journal of History vol. 41, no. 4-5).

Essays on forts, factories, private residences, and plantation buildings erected by the Danes on the

Kea, Ray A., A Cultural and Social History of Ghana from the Seventeenth to the Nineteenth Century. The Gold Coast in the Age of Trans-Atlantic Slave Trade, vol. 1-2, New York: Edwin Mellem Press, 2012.

This comprehensive work examines, from an African perspective, the cultural and social history of the Gold Coast by presenting an analytical and theoretical perspective on the Atlantic African side of the trans-Atlantic slave trade, including a study of subalterns.

Eight papers from a symposium on emancipation in the Danish West Indies and on the Gold Coast.

N. F. S. Grundtvig (1783-1872) was a member of the small Danish anti-slavery committee. He

corresponded with the British and Foreign Anti-Slavery Society and was a member of the Danish parliament.

The history of a small black community transformed, through the nineteenth century, from a group of small cotton and provision estates to community-held and family-owned parcels.

Fonsmark, Anne-Birgitte, *Pissarro. Et møde på Skt. Thomas*, København: Ordrupgaard, 2017. The famous impressionist painter Camille Pissaro (1830-1903) was born and raised on St. Thomas, where he met the Danish painter Fritz Melbye (1826-1869). The two inspired each other and travelled together in the Americas.

Selected writings on the history of St. John from the archives of the St. John Historical Society.

Six papers, including one rendering an overview of the history of Christiansted and five discussing special aspects of the history.

A sociological portrayal of the female coal-bearers in the harbor on St. Thomas, particularly their strikes in 1892 and 1916.

The Danish West Indies as reflected in Danish fiction from the eighteenth century to c.1970.

The book depicts the not very successful labor policy in the Danish West Indies after emancipation and the introduction of indentured Indians on St. Croix, 1863-1873, most of whom returned to India in 1868.

Sebro, Louise, *Mellem Afrikaner og kreol. Etnisk identitet og social navigation i Dansk Vestindien* 1730-1770, Lund: Lunds Universitet, 2010.

Based on a micro study of the Moravian community in the Danish West Indies between 1730 and 1770, the book discusses whether and how enslaved Africans identified themselves with African ethnic groups and how this played a role in their social life.

Simonsen, Gunvor, Slave Stories. Law, Representation, and Gender in the Danish West Indies, Aarhus: Aarhus University Press, 2017.

Account of how enslaved Africans presented themselves before courts in the Danish West Indies, 1755-1848. However, the dialogue between Danish judges and enslaved people did not result very much in influence on the verdicts.

The story of the emergence of Dutch Creole, called 'Negerhollands', in the Danish West Indies in the seventeenth century and of the coming of English Creole around the middle of the nineteenth century.

Dahl, Klaus, *Det vestindiske møblement. En dansk kolonihistorie i 107 kasser*, København: Gyldendal, 2016.

The history of c.250 pieces of furniture, a handful of paintings, and silver services from government buildings in the Danish West Indies.

Dahl, Thorkel og Kjeld de Fine Licht, *Surveys in 1961 on St. Thomas & St. Croix,* Copenhagen: Kunstakademiets Arkitektskoles Forlag, 2004.

The Danish Royal Academy of Fine Arts' architectural surveys, carried out in 1961, in the former Danish West Indies. This is a translation of the Danish edition: *St. Thomas & St. Croix,* København: Kunstakademiets Arkitektskoles Forlag, 2004.

Lunn, Ulla, When Architecture Tells the Story of the Virgin Islands of the United States, Copenhagen: Gad, 2018.

Architectural tradition and style in the former Danish West Indies, illustrated by different sorts of buildings standing today. This is a translation of the Danish version: *Stedet fortæller – om Dansk Vestindien*, København: Gads Forlag, 2016.

Criminal law in the Danish tropical colonies and Greenland, discussed in a comparative international perspective.

Organization, recruitment, service, uniforms, equipment, and arms of Danish soldiers in the West Indies, 1755-1917. Also published in Danish: *Danske soldater i Vestindien. Garff, Joakim, *Kierkegaard's Muse. The Mystery of Regine Olsen*, Princeton: Princeton University Press, 2017.

Regine Olsen (1822-1904) was married to Governor J. F. Schlegel and stayed on St. Croix 1855-1860. Her correspondence provides a fine picture of life among the Danes in the Danish West Indies. This is a translation of the Danish version: *Regines gåde. Historien om Kierkegaards forlovede og Schlegels hustru*, København: Gads Forlag, 2013.

Larsen, Alex Frank, *Legenden om Denmark. Den danske slave, der ændrede USA's historie,* København: Gyldendal, 2013.

The enslaved Denmark Levey (1767-1822) came to St. Thomas and later to Charleston, where he became a free person of color. There, in 1822, he was accused of calling for revolt among the enslaved and was executed.

Larsen, Alex Frank, Kongehusets joker. Fra slavedreng til slotsidol, København: Informations Forlag, 2017.

Kwasi (1750-1822) came as an enslaved boy to St. Croix but nine years old he was sent on to Copenhagen, and from there he was sent as a gift to the Swedish king. After education and nine years' service at the royal court he became a farmer in Sweden.

Palsson, Gisli, *The Man who Stole Himself. The Slave Odyssey of Hans Jonathan*, Chicago: University of Chicago Press, 2016.

Hans Jonathan (1784-1827) was born a slave in St. Croix, but as a boy was sent to Copenhagen. From there he ran away from slavery in Denmark and escaped to Iceland, where he married and lived as a tradesman and farmer. This book has been translated into Danish as *Hans Jonathan*. *Manden som stjal sig selv*, København: Rebel, 2017.

Source Editions

Gronemann, Signe Trolle og Rikke Vindberg, I orkanens øje. Beretninger fra orlogsskibet Valkyriens togt til Dansk Vestindien 1915-1917, København: Dansk Vestindisk Selskab, 2005.

Accounts by officers and ordinary sailors of the Danish man-o-war 'Valkyrien' on conditions on board during the ship's stay in the Danish West Indies from 1915 to 1917.

Highfield, Arnold R., ed., *Hans West's Account of St. Croix in the West Indies*, St. Thomas: The Virgin Islands Humanities Council, 2004.

Schoolmaster West's (1758-1811) descriptions of population, lifestyle, economy, and natural conditions of St. Croix. This is a translation of a Danish journal article from 1791 and his book *Bidrag til Beskrivelse over Ste. Croix ...*, Copenhagen 1793. West was a fervent voice against emancipation.

Highfield, Arnold R., Guide to British Documents for the Danish West Indies and the Virgin Islands during the Colonial Period, 1652 to 1739, St. Croix: Antilles Press, 2010.

This volume offers a review of some of the earliest British sources catalogued in the Calendar of State papers relative to the Danish West Indies and to the British Virgin Islands. These references cover the formative years of these two colonies from the mid-seventeenth century down to the late eighteenth century.

Highfield, Arnold R. ed., Charles Vanderbourg's Report to Ernst Schimmelmann on the Present Conditions of the Negroes on the Schimmelmann Plantations and the Means of Ameliorating Them, St. Croix: Antilles Press 2018.

Vanderbourg (1769-1827) traveled to the Caribbean in 1796 at the behest of Ernst Schimmelmann with instructions to observe conditions among the enslaved laborers on the Schimmelmann plantations in the Danish West Indies and then offer suggestions for improvements. Translations of all official reports (*generalbreve*), sent from Danish officials on the Gold Coast to Copenhagen, 1657-1754, particularly providing information about local African societies and their relations to the Europeans.

Meier, Gudrun und Hartmut Beck, eds., Christian Georg Andreas Oldendorp: Historie der caribischen Inseln Sanct Thomas, Sanct Crux und Sanct Jan, insbesondere der dasigen Neger und der Mission der evangelischen Brüder unter denselben, vol. 1-4, Berlin: Verlag für Wissenschaft und Bildung, 2000-2002.

Oldendorp (1721-1787) was a Moravian missionary who visited the Danish West Indies in the 1760s and wrote a 3000-page report in German. Vol. 1 of the source edition is an introduction to Oldendorp and his work, while vol. 2-4 are the transcribed and annotated report text, including his interviews with enslaved Africans and descriptions of their living conditions and beliefs.

Nørr, Erik og Jesper Thomassen, eds., *Nordatlanten og Troperne. Forvaltningshistoriske kilder fra Færøerne, Grønland, Island og Tropekolonierne*, København: Kildeskriftselskabet, 2007. The book contains a comprehensive section with transcriptions and introductions to twelve categories of archival sources to the history of the Danish West Indies and the Gold Coast.

Tyson, George F., ed., Searching for Truth and Justice. The Writings of Ralph D. de Chabert 1915-1922, St. Croix: Antilles Press, 2009.

The writings of journalist and labor leader de Chabert (1891-1955) sheds light upon labor unrest and the first labor union on St. Croix between 1915 and 1922.

Winsnes, Selena Axelrod, ed., A Reliable Account of the Coast of Guinea (1760) by Ludewig Ferdinand Rømer, Oxford: Oxford University Press, 2000.

Rømers' (1714-1776) account of the Gold Coast and the slave trade around 1750 also includes information about the local population's religion and ways of life. This is a conflation of his two books in Danish: *Tilforladelig Efterretning om Kysten Guinea*, Copenhagen 1760, and *Tilforladelig Efterretning om Negotien paa Kysten Guinea* ..., Copenhagen 1756.

Winsnes, Selena Axelrod, ed., Two Views from Christiansborg Castle, vol.1: A Brief and Truthful Description of a Journey to and from Guinea by Johannes Rask, vol. 2: A Description of the Guinea Coast and Its Inhabitants by H. C. Monrad, Accra: Sub-Saharan Publishers, 2009.

Chaplain Rask's (1678-1744) account of his stay at Fort Christiansborg covers the period 1709-1712. This is a translation of the first edition: *En kort og sandferdig Rejse-Beskrivelse til og fra Guinea*, Trondhjem 1754. Monrad (1780-1825) was a chaplain at Fort Christiansborg 1805-1808. This is a translation af the first edition: *Bidrag til en Skildring af Guinea-Kysten ...*, Copenhagen 1822. Both accounts deal especially with natural conditions, the Africans, slave trade, and Danish plantation efforts.

Winsnes, Selena Axelrod, ed., *A Danish Jew in West Africa, Wulff Joseph Wulff. Biography and Letters 1836-1842*, Trondheim: Norwegian University of Science and Technology, 2004. Wulff (1809-1842) was a trade official from 1836 at Fort Christiansborg on the Gold Coast where he

lived together with the local woman Sara Malm. This is a translation of his letters home and diary, first published as: Carl Behrens, *Da Guinea var dansk ...*, Copenhagen 1917.

The scanty debate in Denmark on the country's role as a colonial power in the West Indies as a contrast to Caribbean demands for reparations and public excuses.

Andersen, Frits og Jakob Ladegaard, red.: *Kampen om de danske slaver. Aktuelle perspektiver på kolonihistorien* Aarhus: Aarhus University Press, 2017.

Twelve essays on the limited role which the history of Caribbean slavery plays in Denmark today and the role it ought to play.

Bastian, Jeannette Allis, Owning Memory. How a Caribbean Community Lost Its Archives and Found Its History, Westport: Libraries Unlimited, 2003.

The book critically examines the relationship between archives, communities, and collective memory in the US Virgin Islands, as the historical records from the former colony reside in Denmark and the United States.

An account of Denmark's colonial legacy in combination with it's consequences for Danish identity today.

This book adopts a global approach to analyzing Danish nationhood, focusing on the global strands which have produced understandings of national selfhood as a consequence of a series of historical and contemporary global encounters.

Portraits of descendants from enslaved in the Danish West Indies.

Sailors, servants, workers, and other Virgin Islanders in Denmark around 1900, described both as individuals and as a group with regard to background, occupation, and social conditions.

Rud, Søren and Søren Ivarsson, red., *Globale og post-koloniale perspektiver på dansk kolonihistorie,* Aarhus: Aarhus Universitetsforlag, 2021.

The book discusses the ongoing debate in Denmark on Danish colonialism and its legacy, including interviews with descendants of slave owners.
